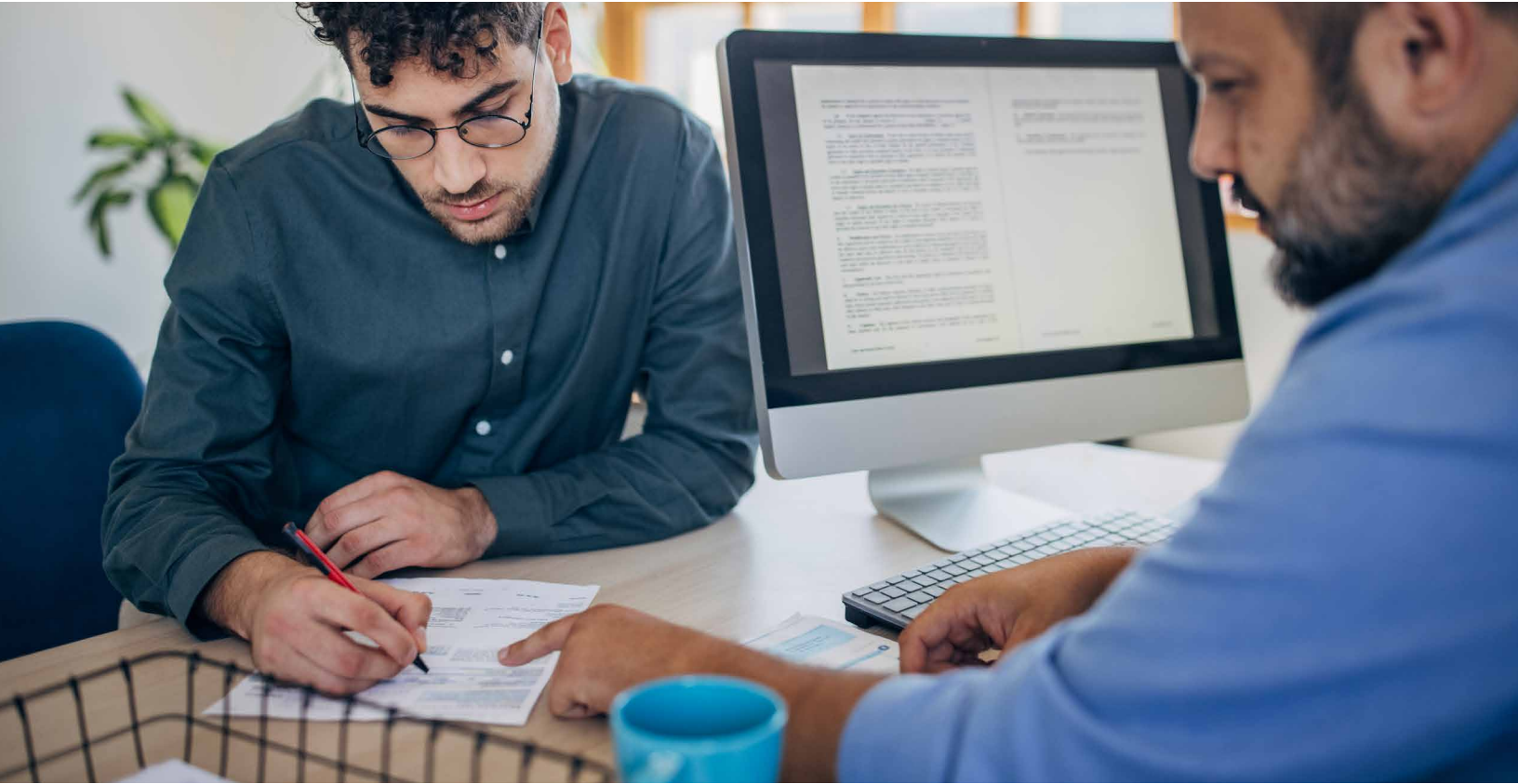




## EFFECTIVE WRITING FOR HEALTH CARE

Effective Writing for Health Care is for professionals seeking to accelerate and elevate communications skills with minimal time away from practice or research activities.

Featuring faculty editors and contributors from the *New England Journal of Medicine*, the Harvard College Writing Program, leading media outlets and grant organizations, this program offers three specialized tracks:

- Writing for Medical and Scientific Journals: Increase the likelihood of a submission being accepted to a medical or scientific journal
- Writing for the Public: Achieve success in communicating ideas and opinions via newspapers, magazines and social media
- Writing Grant Proposals: Gain strategies, best practices and coaching to create more persuasive grant proposals

Throughout the program you will:

- Attend three four-day workshops
- Participate in 60 webinars, on-demand sessions and targeted hands-on writing exercises
- Work in small groups and with writing coaches, editors and faculty members to advance specific writing goals
- Produce a personal capstone project—a submission-ready project with support from a faculty member

## Program Overview

---

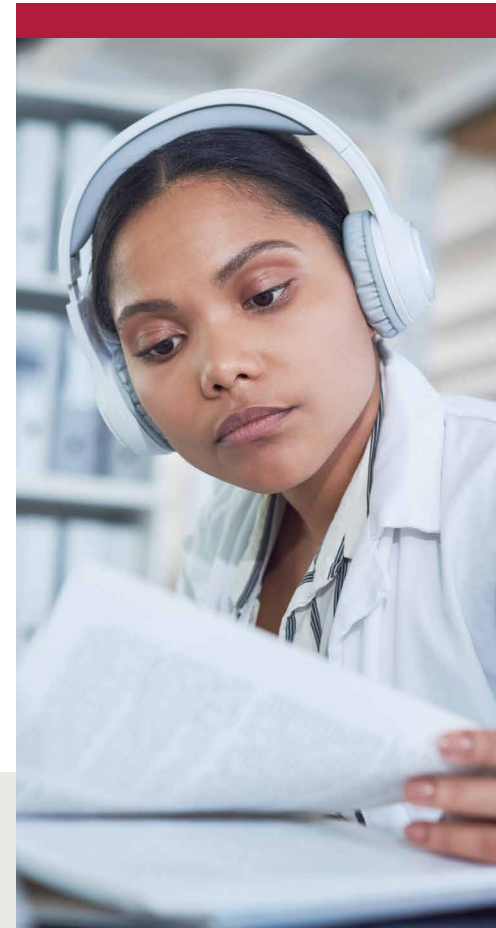
Effective Writing for Health Care spans roughly one year, with three four-day workshops at the beginning, middle and end of the program. The learning model works to elevate your communication skills and depending upon the specific track for which you are enrolled, your ability to:

- Develop a high-impact article for a medical or scientific journal
- Convey your opinions and ideas to the public
- Produce a high-caliber grant proposal

In the first half of the year, you will partake in the Core Curriculum aimed to strengthen key foundational writing skills, such as crafting cogent persuasive arguments, creating cohesive paragraphs, being concise and using strategic grammar. In the second half of the year, every scholar will develop a submission-ready capstone project with support from a Capstone Reviewer, who is chosen based upon the reviewer's expertise in publishing manuscripts, grant writing or writing for the public.

Your Capstone Reviewer will guide you in the creation of your capstone project, including:

- Assisting on the pitch and outline of your writing project
- Reviewing the revised drafts of your capstone
- Providing guidance to help you optimize its value to you and your institution



## Curriculum Highlights

---

The Effective Writing for Health Care certificate program is designed to help you achieve your writing and career objectives through the key Core Curriculum and one of three specialized tracks.

This program features a blended learning model comprising live workshops, self-paced on-demand sessions, live webinars and writing exercises with feedback that work to elevate your writing skills. These exercises can be tailored to your specific writing goals. Each specialized track culminates in a capstone project, where you will develop a submission-ready written work.

**After completing this program, you will have the skills to:**

- Design and craft impactful, effective and persuasive writing
- Utilize detailed reasoning and evidence to defend your academic argument
- Write in a cogent, coherent and cohesive form within the disciplines of science, medicine and health care
- Communicate to diverse audiences with clarity and confidence

This program requires a high level of English proficiency. Our learners typically hold a terminal, doctoral or master's degree in a health-related subject.

During the application process, you will be asked to submit the following documents:

- Curriculum vitae or resume
- Personal statement of up to 500 words on how you will benefit from the program
- A writing sample in support of your application not more than two pages in length
